

ORDER CONDITIONS ARTBOX.PUBLISH Catalogue / Art Statement/ Press release

1. What is the ARTBOX.PUBLISH catalogue

1.1

At ARTBOX.PUBLISH you order a personalized catalogue with your artworks.

2. What does the catalogue contain?

2.1

The catalogue contains pictures of your artworks, an art statement which you can write yourself or have us write it for a fee. The catalogue also contains an imprint.

2.2 Which works of art can I publish in the catalogue?

You are free to choose which works of art you would like to include in your catalogue. It is important that you may only include works of art in your catalogue on which you have the copyright. This means you must have created the artworks yourself, or you have acquired the copyright of the artwork. For example, you may not photograph works of art by another artist and then include them in your catalogue. Unless you have the official permission of the artist who created the artwork.

2.3

The design and content of the catalogue is based on the information you send us when placing your order.

2.4

Before printing the catalogue you will receive a link with which you can view and check your catalogue. You have the possibility to make changes. Your catalogue will not be printed until you have sent us the confirmation for printing by email.

3. What about the copyright of the pictures?

3.1

You may only upload images for your personal catalogue for which you hold the copyright. By ordering a catalogue you confirm that you own all rights to the images.

4. Publication of the catalogue

4.1

In the order form you can specify whether you want to publish your catalogue or just print the number of catalogues you have ordered. If you want to publish the catalogue, your catalogue will receive an official ISBN number and will be listed under the available books. Please read here all details about the publication of your catalogue:!!!!!!!

4.2 Conditions for the publication of the catalogue

If you order us to publish your catalogue, you transfer to ARTBOX.GROUPS GmbH the right to publish your statement, your name and photos of the works of art listed here in this catalogue and to distribute the catalogue.

5. What if I am not satisfied with the catalogue?

5.1

Before the catalogue is finally printed, we will send you a link to view your catalogue. You have to check your catalogue and can inform us of any changes or errors, after that we will send you a corrected sample copy. If everything is in order, you have to send us by email a "good to print", i.e. a confirmation that we can print the catalogue. As soon as you have sent us this confirmation, your catalogue will be printed. From this point on, we can no longer accept any changes or complaints.

6. Delivery of the catalogue

6.1 How delivery is made

The catalogue will be sent directly to your delivery address.

6.2 How long does it take until I receive my catalogues?

6.2.1

If you order a standard catalogue without any additional services, it will take about 5 working days until you receive the "good for printing".

6.2.2

If you order a catalogue with a cover specially designed for you, it takes about 7 working days until you receive the "good for printing".

6.2.3

If you order a catalogue with a statement written by us, it takes about 8 working days until you receive the "Good to Print".

6.2.4

If you order a catalogue with a cover specially designed for you plus a statement written by us, it takes about 8 days until you receive the "Good to Print".

6.2.5

As soon as we have received your "Good to print", we can print the catalogue, from this time it takes 8-10 working days until the catalogue is with you. This depends on your country and the efficiency of your country's customs authorities.

7. Why do I have to order at least 10 pieces?

7.1 Minimum order quantity

In order to be able to offer you the catalogue at this low of a price, we must print a minimum quantity of 10 pieces. The higher your order quantity, the cheaper each individual catalogue will be. The exact price will be calculated directly in the order form.

8. What is included in the price?

8.1

The price includes the design costs of the catalogue, the printing costs and the shipping costs.

8.2

We print and ship from Switzerland, depending on the country, customs duties may apply which are not included in the price!

9. Terms of payment

9.1

Only when we have received the payment of the total amount, we will start with the design of the catalogue.

10. Press release

10.1 What is a press release?

You have the possibility to order a press release for your catalogue or independent of a catalogue order. A press release contains a short description about your art and e.g. about the publication of your catalogue, or about a topic of your choice. The press release must be related to your art. So e.g. report about an exhibition of you or something similar. You have the possibility to publish the press release in all German speaking countries or worldwide. In German-speaking countries we publish press releases only in German, worldwide only in English. The press release reaches over 50,000 press subscribers in German-speaking countries and over 100,000 worldwide.

11. Right of revocation

11.1

In Switzerland, the right of withdrawal only exists if the seller grants it on his own initiative. ARTBOX.GROUPS GmbH is very obliging in this respect. If you would like to cancel your order, please contact us via the e-mail address office@artboxgroups.com. As soon as you have sent us the goods for printing, there is no possibility to cancel the order.

In the event of any discrepancy between this translated version of the General Terms and Conditions and the original German text, the German version shall prevail.

14.3

These GTC and any disputes arising from or in connection with the relationship between ARTBOX.PUBLISH/ ARTBOX.GROUPS shall be governed exclusively by Swiss law, to the exclusion of the conflict of laws provisions and the provisions of the UN Sales Convention (CISG).

14.4

The exclusive place of jurisdiction for all disputes between ARTBOX.PUBLISH/ ARTBOX.GROUPS GmbH is the registered office of ARTBOX.GROUPS GmbH in Zug. ARTBOX.PUBLISH/ ARTBOX.GROUPS is however entitled to sue the customer at his domicile.
